

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.courtlandtech.com and Courtland Technology Industry Inc/ Global Scientific and Technology (CTI Inc) and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Courtland Hospitality Blockchain Company include www.courtlandtech.com and CTI INC. By using the CTI INC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, CTI INC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase CTI INC products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through CTI INC's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties

CTI INC does not sell, rent or lease its customer lists to third parties.

All such third parties are prohibited from using your personal information except to provide these services to CTI INC, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Use of Cookies
